To redeem the \$50 Welcome Bonus Promotion, you must follow these steps:

- 1. Register and verify your account with EMAR Markets.
- 2. Login to your EMAR Markets Trader Dashboard and deposit 15 USD or more into your Welcome Bonus Account using a local bank transfer only.
- 3. Your bonus will be credited to your account within one working day.

Platform Eligibility & Limitation

The Welcome Bonus is available exclusively on MetaTrader 5 (MT5) and cTrader platforms. Each client is permitted to open only **one** (1) Welcome Bonus account, on either one of these platforms — not both. Once the account has been created on a selected platform, no change or migration to another platform will be permitted. Clients are advised to select their preferred platform carefully before applying for the Welcome Bonus.

Terms & Conditions

Here is a summary of the important points:

- 1. The promotion period starts on May 21st until June 21st, 2025
- 2. The bonus is only available to new sign-ups, and only their first deposit is eligible for the promotion. Existing clients are not eligible.
- 3. Clients must be new and verified to be eligible for the promotion.
- 4. The bonus will be credited as actual funds for trading in the client's account.
- 5. The bonus credit supports a floating margin.



- Clients who withdraw any amount from the initial deposit that was credited for the promotion or transfer funds to another trading account will have their total credit deducted.
- 7. The bonus cannot be added to internal transfer deposits or deposits from other contests/promotions.
- 8. EMAR Markets has the right to reject a client's bonus application or contest participation at any time.
- 9. EMAR Markets reserves the right to terminate a client's incentive at any time.
- 10. Any circumstance not covered by the regulations is up to EMAR Markets's discretion.
- 11. EMAR Markets reserves the right to change, update or cancel this promotion without prior notice.
- 12. Fraudulent activity will nullify all previously credited trading bonuses of the Eligible Client's real trading Accounts with EMAR Markets and/or any and all transactions carried and/or profits or losses in that Account.

- 13. No partner's commissions are paid for trading-on-trading benefit funds.
- 14. Profits from trading-on-Trading Bonus Accounts may be withdrawn anytime, provided that the trading volume in the relevant real trading Account reaches at least 3 lots.



- 15. Clients may withdraw up to \$200 of the profit generated from the trading of this credit bonus. Any profits made on top of this amount will be removed at the time.
- 16. The bonus given in the Welcome Bonus account will be deducted if there is no trading activity within 30 calendar days from the last day of trade.
- 17. Clients must follow all instructions and may only be verified by EMAR Markets (pty) Ltd. EMAR Markets reserves the right to request evidence from the client to authenticate and verify that winning clients have taken all the necessary steps required to be eligible for the promotion. EMAR Markets reserves the right to modify, cancel, and limit any promotion or offer.
- 18. High Frequency Trading (HFT), including any form of automated or algorithmic trading intended to execute an unusually high number of transactions in a short period of time, is strictly prohibited on the Welcome Bonus Account. Any client found engaging in HFT or using Expert Advisors (EAs), trading bots, or similar tools will have their Welcome Bonus account immediately disqualified, and all profits generated will be forfeited without prior notice.
- 19. Clients must engage in trading for a minimum of 15 days before they are eligible to proceed with a withdrawal.
- 20. The client's country IP address and country of residential address must match during registration. Registrations made using VPNs or any IP masking tools will render the client ineligible to claim the bonus.
